Notice is hereby given that the Board of Review (BOR) will hold their organizational meeting at the Office of the Supervisor Tuesday, March 7, 2023 at 5:30p.m., to review the 2023 tax assessment roll as prepared by the assessor.

The Board of Review meetings for public inspection of the 2023 tax assessment roll will be held at the Township Hall, Monday, March 13, 2023 from 9:00 a.m. until 12:00 noon and from 1:00 p.m. until 4:00 p.m., and, Thursday, March, 16, 2023 from 1:00 p.m. to 4:00 p.m. and from 6:00 p.m. until 9:00 p.m. Property owners are encouraged to attend the Board of Review meetings to review their 2023 assessments. Owners and resident taxpayers may protest to the Board by letter, or e-mail (office@littletraversetownship.org). Letters must be postmarked, or e-mails must be dated by March 18, 2023. The final meeting of the BOR will be held at the Twp. Hall Thursday, March 23, 2023 at 9:00 a.m. to review late appeals and to certify the 2023 assessment roll.

Contact your Assessor. If you have questions or concerns about your assessment, please contact your assessor. He may be able to address your questions and concerns without you having to appeal to the March Board of Review.

Protest in Writing. Taxpayers are encouraged to submit their protest to the Board of Review in writing to the mailing address provided in the March Board of Review Appeal section of the enclosed Notice of Assessment.

Ratios and multipliers are subject to adjustment by the Assessor, the Board of Review, Emmet County, and the State Tax Commission. The inflation rate multiplier for 2023 is 1.05 %.
